It was then moved Welton and seconded by Stalzer to be approved and the clerk is authorized to issue warrants in payment of same. Ayes – Faircloth, Stalzer and Welton, Carried. Absent – Daters, Vanderah.

The council members tabled the flooring for the shelter house until next meeting.

Kim Elder and Matthew Vogeler presented to the city council that the city will now be responsible for insuring the new sirens in Haverhill. Marshall county will retain control of the hardware, testing and setting off alarms. Cities will now all be responsible for insurance and maintenance.

A motion was made by Welton and seconded by Stalzer to approve Heart of Iowa an installment of a permanent IP address for the city and the monthly fee associated with it. Ayes – Faircloth, Stalzer and Welton, Carried. Absent – Daters, Vanderah.

The council wanted to remind residence of Haverhill of the city ordinances for abandoned vehicles as stated below:

(Code of Iowa, Sec. 3641.1)

3-10-2 DEFINITIONS. For the purpose of this chapter, the following terms are defined as follows:

1. "Abandoned vehicle" means any of the following:

- a. A vehicle that has been left unattended on public property for more than twenty-four hours and lacks current registration plates or two or more wheels or other parts which render the vehicle inoperable; or unsafe or
- b. A vehicle that has remained illegally on public property for more than twenty-four hours; or
- c. A vehicle that has been unlawfully parked on private property or has been placed on private property without the consent of the owner or person in control of the property for more than twenty-four hours; or
- d. A vehicle that has been legally impounded by order of the Marshall County Sherriff's Office and has not been reclaimed for a period of ten days; or
- e. Any vehicle parked on the street determined by the Marshall County Sherriff's Office to create a hazard to other vehicular traffic.

(Code of Iowa, Sec. 321.89(1)(b))

It was then moved by Stalzer and seconded by Vanderah that the meeting be adjourned at 7:47. Ayes – Faircloth, Stalzer and Welton, Carried. Absent – Daters, Vanderah.
